- Hall hire for the Les Munro Centre, Piopio Memorial Hall and Te Kuiti Railway Station Buildings 1 and 3
- A full or partial contribution will be considered
- Maximum of two applications per financial year is considered

What will not be considered for a Hall Hire Contribution?

- Hall hire of a private nature
- Hall hire that has commenced or has been completed at time of application
- Organisations with overdue Accountability Reports from Waitomo District Council grant funding
