Our roading is currently in a very substandard condition following a major weather event in Feb 2022. We are already put at risk on our roads on a daily basis as a result of local logging operations and the service vehicles that travel to Taharoa Ironsands Mining Operation. The impact of having a massive increase of heavy vehicular activity on our roads (10215 trips estimated in the proposal) would put our farming operations, local travel and tourist travel at hugely increased risk of accidents in our remote area. Our roads are also very narrow in places with virtually no passing opportunities. The noise pollution created by heavy trucks descending the steep incline above our village would impact on our peace and quiet – currently we hear Logging Trucks in the early morning. It would appear Ventus has no plan or obligation to upgrade, maintain or reinstate roading following this massive undertaking.
