Proposal for Closure of Road/Street To Ordinary Vehicular Traffic

PURSUANT to the Transport (Vehicular Traffic Road Closure) Regulations 1965, notice is hereby given that the Waitomo District Council, for the purpose of the Targa New Zealand 2012 Rally proposes to close the following roads/streets to ordinary vehicular traffic for the periods indicated:

Date: **Tuesday 23 October 2012**

Period of Closure: 12.10pm to 3.40pm

Streets/Roads: **Waitomo Valley Road** - Starting 1.10kms from its intersection with SH37 (just north of Woodlyn Park), to the district boundary.

Haurua Road - Starting from the district boundary to its intersection with SH37. Including intersections with: Waihohonu Road (No Exit)

Note: To assist with the stage security, the closure is also to include 100 metres of EACH adjoining road, from where it intersects with the road being applied for.

Date: **Tuesday 23 October 2012**

Period of Closure: 9.40am to 2.10pm

Streets/Roads: Barber Road - Starting from the district boundary, to its intersection with Tahaia Bush and Rangitoto Roads.

Rangitoto Road - Starting from its intersection with Barber and Tahaia Bush Roads, to finish just before the driveway to Te Kuiti Meat Processors and House 91, which is 880 metres from its intersection with The Esplanade. Including intersections with: Thompson Road (No Exit), Pururu West Road (No Exit), Pururu East Road (No Exit), Ngapeke Road, Ahoroa Road (No Exit), and Tate Road (No Exit).

Note: To assist with the stage security, the closure is also to include 100 metres of EACH adjoining road, from where it intersects with the road being applied for.

Date: **Tuesday 23 October 2012**

Period of Closure: 12.45pm to 5.15pm

Streets/Roads: Kawhia Harbour Road - starting from the district boundary to its intersection with Te Waitere Road. Including intersections with: Brown Road (No Exit), and Willow Point Road (No Exit).

Te Waitere Road - From its intersection with Kawhia Harbour Road to its intersection with Taharoa Road.

Taharoa Road - from its intersection with Te Waitere Roads to finish at its intersection with Te Anga and Marakopa Roads. Including intersections with: Taumatatotara West Road (No Exit) and Taumatatotara East Road (No Exit).

Marokopa Road - from its intersection with Te Anga and Taharoa Roads to finish at house No 933, (500 meters past its intersection with Kairimu Road, (No Exit). Including intersections with: Coutts Road (No Exit), Kairimu Road, (No Exit), Te Karaka Road (no exit).

Note: To assist with the stage security, the closure is also to include 100 metres of EACH adjoining road, from where it intersects with the road being applied for.

Date: **Tuesday 23 October 2012**

Period of Closure: 2.05pm to 6.05pm

Streets/Roads: Mangatua Road - Starting from the start of the tar seal (approximately 5km south of Pomerangai Road), to its intersection with Manganui and Waikawau Roads.

Manganui Road - From its intersection with Mangatua and Waikawau Roads to finish at its intersection with Taumatamaire Road. Including Intersection(s) with: Ordish Road (No Exit) and Crawford Road (No Exit).

Note: To assist with the stage security, the closure is also to include 100 metres of EACH adjoining road, from where it intersects with the road being applied for.

Date: **Wednesday 24 October 2012**

Period of Closure: 2.15pm to 5.45pm

Streets/Roads: Waimiha Road - starting from the district boundary to its intersection with State Highway 30. Including intersections with: Tapuwae Road.

Any person objecting to the proposal is called upon to lodge notice of objection and grounds thereof in writing, before 5.00pm on Tuesday 25th September 2012 at the office of Waitomo District Council, Queen Street, Te Kuiti.
