for a special licence pursuant to section 138
of the Act

DECISION OF THE WAITOMO DISTRICT LICENSING COMMITTEE

- 1. The application for an on-site special licence is granted. The special licence may issue immediately.
- Lynette Adams is authorised to sell and supply alcohol, on the premises situated at Mahoenui Memorial Hall, State Highway 3, Mahoenui to any person attending the 2021 Mahoenui Pig Hunting Competition.
- 3. This licence is subject to the following conditions:
 - (a) A copy of this licence with all the conditions must be displayed in a prominent place so all persons can read it and all staff must be familiar with the conditions.
 - (b) Alcohol may be sold on Saturday 3 September 2019, from 12.00 midday to 10.00pm.

(c) The area where alcohol is to be sold and consumed is described in the plan date stamped as received by the Waitomo District Licensing Committee on 28 June 2021 and no alcohol is to be taken out of this area.

(d) The holder of a manager's certificate shall be on duty and on the premises at all times alcohol is sold and their name shall be on display.

(e) The entire premises is undesignated.

(f) There must be no sale or supply of alcohol to minors or intoxicated persons and there must be displayed appropriate signs detailing these restrictions

(g) Drinking water must be freely available from the bar and this must be clear to customers while the premises is open for the sale and supply of alcohol.

(h) Food must be available for consumption on the premises at all times the premises is open for the sale of alcohol in accordance with the menu submitted with the application for this licence, or variations of a similar range and standard.

(j) A range of low-alcohol and non-alcoholic drinks must be available at all times when the premises is open for the sale of alcohol.

(k) Sober drivers must be made available to transport patrons from the premises if required and this assistance must be displayed in a notice to patrons.

REASONS

- This is an application by Lynette Adams for a special licence for the 2019 Mahoenui Pig Hunting Competition to be held at Mahoenui Memorial Hall, State Highway 3, Mahoenui. The application was filed more than 20 working days prior to the event as required by section 137.
- 2. The Liquor Licensing Inspector, Police and Medical Officer of Health have no objection to this application for a special licence (s 141). Accordingly, this application is decided on the papers (s 202).
- 3. The purpose of the Act is to put in place a new system of control over the sale and supply of alcohol (s 3). The object of the Act is to ensure that the sale and supply of alcohol is undertaken safely and responsibly, and the harm caused by excessive or inappropriate consumption of alcohol is minimised (s 4).
- 4. In deciding whether to grant a special licence the Waitomo District Licensing Committee must have regard to the criteria in s 142 of the Act. Therefore, this committee must consider the following questions within the framework of the purpose and object of the Act:

a) What is the nature of the event? Does the applicant propose to engage in the sale of goods or provision of services other than those directly relating to the sale of alcohol, low-alcohol refreshments, non-alcoholic refreshments and food?

b) Is the applicant suitable?

c) Will the amenity and good order of the locality be reduced to more than a minor extent by the effects of the issue of the licence?

d) Are the days and hours during which the applicant proposes to sell alcohol reasonable?

e) Is the design and layout of the premises suitable? Are any areas of the premises designated restricted or supervised areas?

f) Does the applicant have appropriate systems, staff and training to comply with the law? What steps will the applicant take to ensure that alcohol is not sold to prohibited persons?

g) What proposals does the applicant have in relation to the sale and supply of non-alcoholic drinks and food, low-alcohol drinks and the provision of help with or information about alternative forms of transport from the premises?

h) Have the Inspector, Police and Medical Officer of Health raised any relevant considerations?i) Does the application comply with the Waitomo District Local Alcohol Policy?

 The licensing committee may refuse a special licence even if there was no objection to the application (s 144). Sections 146 – 149 of the Act outline the compulsory and discretionary conditions for a special licence.

Should the special licence be granted?

- 6. The 2021 Mahoenui Pig Hunting Competition is a fundraising event for Mahoenui Hall and less than 100 people are expected to attend the event. The licensing committee is satisfied that the proposed hours are reasonable. The application complies with the Waitomo District Local Alcohol Policy.
- 7. The licensing committee is satisfied that Lynette Adams is a suitable applicant to hold a special licence. Lynette Adams is a respected member of the community and was involved in similar events over the past

three years and no adverse issues have been reported. Lynette will be giving the proceeds of the event to the Mahoenui Hall Committee, for the upkeep of the hall.

- 8. The licensing committee is satisfied that the design and layout of the premises is suitable given the temporary nature of the licence. The licensed area includes a large hall with a kitchen and supper room containing a bar servery as well as an outdoor paddock area delineated by a fence. The entire licensed area is undesignated. This is appropriate for this type of low-risk family orientated event.
- 9. The licensing committee is satisfied that suitable measures will be taken to ensure that alcohol is sold and supplied responsibly, and that harm caused by inappropriate or excessive consumption of alcohol is minimised. A certificated Duty Manager will ensure that the event complies with the Act and will be assisted by committee members. Given the nature of the event and the venue it is not likely that the issue of the special licence will adversely affect neighbouring properties.
- 10. The licensing committee is satisfied that the applicant will provide sufficient food, low-alcohol and nonalcoholic refreshments. Free water will also be provided. Sober drivers will be promoted as a safe option for transport home from the event.

Conclusion

11. The licensing committee is satisfied that the grant of the special licence with the appropriate conditions will ensure the safe and responsible supply of alcohol and the minimisation of harm caused by excessive or inappropriate use of alcohol. Therefore, the application for a special licence is granted.
