PROPOSAL\_1\_SAFE\_COMMUNITIES: I support Option 3 for proposal 1

SAFE\_COMMUNITIES\_COMMENTS: Maniapoto Family Violence Intervention Network fully supports this proposal for the establishment of an accredited Safe Community programme and commends the council for including this in their 2015 - 2015 LT plan.

However we feel option 1. of \$60,000 is insufficient to fulfil this promising investment in our communities social needs.

We encourage the council to be courageous and to create an even more robust model to extends what can be achieved.

This would demonstrate a greater commitment to a "safe and thriving community" across all socio-economic groups in the district and be the envy of other regions.

Therefore MFVIN recommends option 3. - that the WDC make this area an even greater priority and allows for more funding to be put towards it. This will allow for meaningful and tangible outcomes to be achieved.
