Dog Control Fees 2012/2013

Public Notice is hereby given that the Dog Registration Fees for the 2012/2013 financial year have been set by Council resolution in various categories as set out below:

- A basic dog registration fee of \$149 (incl of GST) in respect of dogs having attained the age of 3 months.
- A \$96 dog registration fee (incl of GST) b) in respect of any dog in the urban area which is kept in a manner which complies with the provisions of the Dog Control Act 1996.
- c) A \$75 dog registration fee (incl of GST) in respect of any dog in the urban area which has been spayed or neutered.
- A \$54 dog registration fee (incl of GST) d) in respect of any dog where the owner of that dog is covered by Council's Selected Owners Policy.
- A \$33 dog registration fee (incl of GST) e) in respect of any dog in the rural area which is kept in a manner which complies with the provisions of the Dog Control Act 1996.

f) A late registration fee of 50% of the fee that would have been payable if that dog had been registered on the first day of the registration year. The late fee will be payable in respect of dogs required to be but which remain unregistered on or after the 1 August 2012.

These dog fees must be paid by 4.30pm on July 31, 2012 at the office of Waitomo Animal Control, located in Chapman's Shoe Inn, Rora Street, Te Kuiti or by posting the registration forms and fees to Waitomo Animal Control, PO Box 97, Te Kuiti.

Dog owners who are new residents of the Waitomo District are required to contact Waitomo Animal Control at the above address.

Note: Registration fees will NOT be collected at the Council Office, Queen Street, Te Kuiti.
