The Te Kuiti Kiwi Camp: A flop in the way it has been set up. No area for tents.

Te Araroa Trail

From October to March each summer there is a huge influx of trampers from the Te Araroa Trail who pass through Te Kuiti.

All need accommodation of some sort. Where do approximately 1000 people stay?

A few stay in motels, others have been traditionally taken in by "Trail Angels".

"Trail Angels" are not guaranteed accommodation, and having 350+ people stay at your home over a space of 4 months is not necessarily sustainable ongoing over consecutive summers.

Many of these trampers use Te Kuiti for a 'Zero" rest day.

Why should council be concerned about people who are just out doing "their thing".

Our local business community benefit hugely from this influx.

The purchase of filling, rewarding meals on arrival to town. (Take aways, restaurants, cafes all benefit)

The local Laundromats are well used.

The resupply – shopping for a weeks' worth of food to sustain over the next stretch of trail.

The repair and replacement of equipment.

The return customers – many Overseas people remain in NZ for some time travelling.

They return to places they enjoyed, they tell friends, they bring others to our town.

All brining further income.

Other users issue.

There is another segment of our community using the facilities.

With the removal of amenities block what will happen?

I understand there is a growing use by

Homeless people who live in their cars, or tents hidden in other places.

Toilets, showers are frequently used.

It has been noticed that the showers are being used by more and more in the community who have houses but no hot water.

People are seen to shower then leave for work or school in the mornings.

Possible Solution

Firstly I know the response from some will be "It is not council responsibility to provide accommodation".

Correct, but if council still want:

"A prosperous district

We enable a thriving and sustainable economy to create greater benefits for everyone."

Is it possible a manger or lease arrangement would improve the income?

Improved space to accommodate tents.

Not just for Te Araroa Trail walkers – there is a huge sector of NZ population who still love camping.

If this Kiwi Camp is dismantled then we will have another issue, how will council address that?

Maybe better economics wise to rectify this issue than start over.
