Purpose

- 1.1 The purpose of this business paper is to set out the proposed timetable for Council to hear Submitters speak in support of their submissions to the 21023 Māori Representation Review, to formally accept any late submissions received and to refer the late and verbal submissions for deliberation at the Council meeting scheduled for Tuesday 17 October 2023.
- 1.2 Distributed separately and forming part of this business paper is a Submission Booklet comprising copies of all submissions received to the 2023 Māori Representation Review.

Important Notes for a Hearing:

- 1 Elected Members are reminded of their responsibility to consider all submissions with an open mind and without any pre-determination.

This does not mean that Members' cannot have an opinion – it simply means that as an elected Member you must be prepared to listen to alternative views and to change your own views should you be convinced.
- 2 Elected Members may only ask questions for clarification purposes.
- 3 No debate is to be entered into between any Elected Member(s) and Submitter(s).

Commentary

- 2.1 At the consultation closing deadline of midnight on Sunday 17 September 2023 a total of sixty (60) submissions had been received.
- 2.2 Late Submissions**
- 2.3 Notification was also received that Te Piruru Papakainga Marae and Te Whare ki Tokanganui-a-Noho would be submitting late submissions and that Te Whare ki Tokanganui-a-Noho wished to be heard at the Hearing.
- 2.4 One other late submission has been received making a total of three (3) late submissions.
- 2.5 It is recommended that the late submissions be received and referred for deliberation at the Deliberations meeting scheduled for Tuesday 17 October 2023.
- 2.6 Hearings Process**
- 2.7 Of the sixty two (62) submissions received to date, eleven (11) Submitters had indicated they wish to be heard in support of their written submissions.
- 2.8 At the time of preparing this Agenda, the written submission from Te Whare ki Tokanganui-a-Noho has not been received, however we are informed that a late submission is still to be submitted. Advice has also been provided that there will be no speakers at the Hearing for the Te Whare ki Tokanganui-a-Noho submission.

- 2.13 This earlier date coincides with the Deliberations Meeting already scheduled.
- 2.14 All Submitters have been notified of this change and it was also included in an Amended Meeting Schedule published in the King Country News on 28 September 2023.
