## Notice for Closure of Road/Street To Ordinary Vehicular Traffic

PURSUANT to the Transport (Vehicular Traffic Road Closure) Regulations 1965, notice is hereby given that the Waitomo District Council, for the purpose of the **THE GREAT NZ MUSTER 2015** will close the following roads/streets to ordinary vehicular traffic for the periods indicated:

**Date: 11 April 2015**

**Period of Closure: 7.00 a.m. to 6.00 p.m**

**Streets/Roads:** Rora Street from Ward Street to South End Loop; King Street East from Rora Street to Taupiri Street; Sheridan Street from Rora Street to Taupiri Street.

**Alternative Route/s:** Alexandra Street to Taupiri Street to Lawrence Street to Awakino Road or Carroll Street.

It will be an offence under the above regulations for any person otherwise than under authority to use the road/street for ordinary vehicular traffic during this period of closure.

## Repairs to Bridge 14 at the Kawhia Harbour Road Junction with Waitere Road

Emmetts Civil Construction Ltd of Wanganui, on behalf of the Waitomo District Council, is to carry out bridge reconstruction work at the Kawhia Harbour Road junction with Te Waitere Road, by installing precast concrete span units with back-walls over culvert 14.

Work is to commence on Monday 13 April 2015 with an expected completion date (weather permitting) of 26 April 2015.

Work will be carried out during daylight hours Monday to Friday, as well as on Saturday 25 April and Sunday 26 April, 2015.

Due to the necessity to complete the project in two halves, the site will be restricted to one lane traffic, with stop/go traffic control during day time and appropriate traffic signs (give way) during night time.

Traffic will be managed through the site but short delays can be expected. For the safety of motorists and site staff, speed restrictions will be enforced on both sides of the construction site.

Emmetts Civil Construction Ltd advises that construction operations will cause some noise and vibration, and regrets any inconvenience caused.

Vehicle access to and from all affected properties will be maintained at all times and it is important that road users follow directions of site Traffic Management staff.

Full road closures may be implemented for limited periods of up to ten minutes, in order to enhance road user safety during specific heavy lifting operations.
