Thanks for your email sent after our telephone discussion on 27/04/18.

I confirm that your summary of my thoughts in regards to the current requirement by WDC to go through the application process annualy for Rates Remmission for Properties used Jointly as a Single Unit is accurate.

I do not understand the logic in having to go through this process each year if there have been no changes.

If required, I would be happy to receive, sign & return, an annual declaration from you, confirming whether or not any changes have occured. I suggest that it could be made clear in the covering letter with the declaration that no rates remission will be agreed to by WDC unless the completed & signed declaration form is returned by the stipulated date in the letter.

At the moment I have to somehow try & remember the current cut of date for applications (30th April) & ensure I have lodged my application form. I have been informed by WDC If I forget then I miss out on any rates remission.

As stated in your email this would also bring your process into line with Waikato Regional Council who currently apply the process that I am proposing you consider adopting.

I shall, as you have suggested, have a look at your consultation document and if I have any further feedback shall provide that.
