

# Special Licence

## For Premises

Sections 22 and 64, Sale and Supply of Alcohol Act 2012

**DLC No: SP1491**

**Pursuant** to the Sale and Supply of Alcohol Act 2012, New Zealand Shearing Championships Incorporated is authorised to sell and supply alcohol, on the premises situated at 8 King Street East, Te Kuiti and known as Les Munro Centre to any person attending the following occasion or event (or series of occasions or events):

## New Zealand Shearing & Wool Handling Championships 2024

### Conditions

This licence is subject to the following conditions:

- (a) A copy of this licence with all the conditions must be displayed in a prominent place so all persons can read it and all staff must be familiar with the conditions.
- (b) Alcohol may be sold under the licence only on the following days and during the following hours:
  - Thursday 4 April 2024, from 6.00pm to 11.00pm
  - Friday 5 April 2024, from 5.30pm to 11.00pm
  - Saturday 6 April 2023, from 6.30pm to 2.00am the following day (Bar to close at 1.00am).
- (c) Alcohol may be sold or supplied to people present participating in the event this licence is issued for.
- (d) The licensee must comply with the Alcohol Management Plan supplied with the application.
- (e) The area where alcohol is to be sold and consumed is described in the plan received via email by the Waitomo District Licensing Committee on 21 February 2024 and no alcohol is to be taken out of this area.
- (f) A properly appointed certificated must be on duty and on the premises at all times when the premises is open for the sale of alcohol. If a duty manager is not present, then there must be no alcohol sales and a notice displayed advising the public of this fact.
  - a. All staff will be trained in their responsibilities under the Act;
  - b. Evidence of age documents will be requested from any person appearing to be under the age of 25.
  - c. There must be no consumption of alcohol by staff or managers immediately before or during their shifts.
- (g) There must be no sale or supply of alcohol to minors or intoxicated persons and there must be displayed at every point-of-sale appropriate signs detailing these restrictions.
- (h) Drinking water must be freely available from the bar, lobby, main hall and this must be clear to customers while the premises is open for the sale and supply of alcohol.
- (i) Food must be available for consumption on the premises at all times the premises is open for the sale of alcohol in accordance with the menu submitted with the application for this licence.
- (j) A range of low-alcohol and non-alcoholic drinks must be available at all times when the premises is open for the sale of alcohol.
- (k) A telephone must be freely available for customers to call for transport and staff must assist if required. Sober drivers must be made available to transport patrons from the premises and this assistance must be displayed in a notice to patrons.
- (l) The entire premises is undesignated.
