#### 1. Introduction

#### 1.1 Qualifications and Experience

- 1. My name is Predrag (PJ) Draca. I am employed by the Waitomo District Council as a Senior Planner.
- 2. I hold the qualifications of Bachelor of Environmental Planning- Terrestrial Environmental Stream from the University of Waikato.
- 3. I have been employed in planning roles in both private and local government for almost 10 years. I have been employed by Waitomo District Council as the Senior Planner since September 2020. In this role I am responsible for the administration of the Operative Waitomo District Plan and have been assisting with the drafting of the Proposed Waitomo District Plan when required.

#### 1.4 Preparation of this report

- 7. This report considers the submissions and further submissions that were received in relation to Chapter 48 Natural Open Space Zone.
- 8. The data, information, facts, and assumptions I have considered in forming my opinions are set out in my evidence. Where I have set out opinions in my evidence, I have given reasons for those opinions. I have not omitted to consider material facts known to me that might alter or detract from the opinions expressed.

#### 2. Scope of Report

#### 2.1 Matters addressed by this report

9. This report is prepared in accordance with Section 42A of the Resource Management Act 1991. This report considers submissions and further submissions that were received by the Council in relation to the provisions of Chapter 48 - Natural Open Space Zone (NOSZ) within the Proposed Waitomo District Plan. Chapter 48 – NOSZ manages the effects of activities on reserves on public and private land, which is generally used for recreational and conservation activities. Other effects and activities are addressed in various Section 42A reports, such as temporary activities, and Ecosystems & indigenous biodiversity.

#### 2.2 Overview of the topic / chapter

- 10. This manages the effects of activities on reserves on public and private land, which is generally used for recreational and conservation activities. Land within the NOSZ often has high natural, ecological, landscape, cultural and heritage values and plays an important role in protecting and increasing the populations of threatened and endangered species.
- 11. Activities on Council owned and/or administered reserves are controlled by the provisions of the Reserves Act 1977 the Conservation Act 1987 and to some private land that is the subject of covenants under the Queen Elizabeth II National Trust. Limited areas of private land which have high conservation values are also included in the NOSZ.

#### 2.3 Statutory Requirements

12. The PDP has been prepared in accordance with the Council's functions under section 31 of the RMA; Part 2 of the RMA; the requirements of sections 74 and 75, and its obligation to prepare, and have particular regard to, an evaluation report under section 32 of the RMA, any further evaluation required by section 32AA of the RMA; any national policy statement, national planning standards. Regard has also been given to the relevant regional plans.

#### 2.4 Procedural matters

13. At the time of writing this Section 42A report there have not been any prehearing conferences, clause 8AA meetings or expert witness conferencing in relation to submissions on this topic.

#### 3. Consideration of submissions received

#### 3.1 Overview of submissions

14. A total of 26 submissions and 21 further submissions have been received on the NOSZ Chapter. In total 16 submissions sought the retention of existing provisions, 9 submissions sought amendments to provisions as notified, and 1 submission sought the addition of a new performance standard.

#### 3.2 Structure of this report

- 15. Given the relatively low number of submissions and further submissions received on this chapter, the Section 42A report is structured by submissions that have requested retention of the provisions as notified, and then those seeking relief thereafter.
- 16. The assessment of submissions generally follows the following format: submission information; relief sought by the submitter, the recommendation and if required, any amendments to the plan.

#### Analysis and recommendation

- 17. NOSZ-P2.7 specifically requires that there is adequate existing or planned infrastructure to service the activity and or development. It is considered that the wording 'adequate existing or planned infrastructure' would also include infrastructure for firefighting purposes as such the suggested additional standard by FENZ is not considered necessary.
- 18. <u>Section 32AA:</u> No changes are recommended as a result of this submission. A section 32AA evaluation is not required.

#### Analysis and recommendation

- 22. Forest and Bird have requested an amendment to the Overview, NOSZ-O1, NOSZ-O2, NOSZ-O4 and NOSZ-P1.4 to include the term "indigenous biodiversity" in all of these provisions.
- 23. It is considered that indigenous biodiversity does not need to be specifically referenced in the Overview, Objectives and Policies, as it is provided for in the terms natural and ecological, which would be considered to include indigenous biodiversity. Also, specific objectives, policies and rules for the protection of indigenous biodiversity are provided in Chapter 26 -

Ecosystems & indigenous biodiversity and as such the suggested addition is not required.

24. Heli A1 Limited, New Zealand Agricultural Aviation Association and the New Zealand Helicopter Association have all made submissions seeking clarification that the use of weed and pest control and the intermittent use of aircraft for conservation purposes would be a permitted activity. It is considered that the use of an aircraft for weed, and pest management should be a permitted activity and meets the definition of 'Conservation Activities' in Chapter 9, which is set out below:

"means any activity that involves the preservation and protection of indigenous habitat, flora and fauna that fundamentally benefits indigenous biodiversity and safeguards it for future generations"

- 25. It is considered that conservation activities and pest management on public conservation land and reserves administered by Waitomo District Council are provided for within the Waitomo District Comprehensive Reserve Management Plan and the Waikato or Wanganui Conservation Management Strategy (NOSZ-R4.7 and 4.8). Also, HW-R7 provides for vegetation clearance outside of SNAs across all zones, which would be the applicable provision for weed control.
- 26. <u>Section 32AA:</u> No changes are recommended as a result of these submissions. A section 32AA evaluation is not required.

#### 4. Conclusion

Submissions have been received in support of, and in opposition to the notified provisions of the proposed district plan. Having considered all the submissions and reviewed all relevant statutory and non-statutory documents, it is recommended that no amendments are made to this Chapter.

For the reasons set out in the section 32AA evaluation outlined throughout this report, it is considered that the proposed objectives and provisions, with the recommended amendments, will be the most appropriate means to:

- Achieve the purpose of the Resource Management Act 1991 where it is necessary to revert to Part 2 and otherwise give effect to higher order planning documents, in respect to the proposed objectives; and
- Achieve the relevant objectives of the proposed district plan, in respect to the proposed provisions.
