4. Criteria and Conditions of Consent

- Owner must meet special owner criteria as set out in the Dog Control Policy.
- 2. The property must have the physical suitability of land to hold more than two dogs.
- 3. Written approval must be obtained from neighbours on all sides of the applicants property and submitted with this application.
- Approval for dogs permitted to remain or to be kept on the property at any one time is limited to the dogs listed above.
- 5. Consent is given solely to the owner(s) named above. It may not be transferred or assigned to anyone else.
- All dogs on the property must be supervised and housed in such a manner that no nuisance to neighbours is caused by inadequate dog control, noise or poor hygiene standards.
- Kennels must be sited a minimum of 1 metre from the boundary fence.

- If any further dogs are acquired or any dogs disposed of, WDC must be notified immediately.
- All dogs must be kept and controlled in accordance with the requirements of the Dog Control Act 1996 and Waitomo District Dog Control Bylaw 2015.
- Any breach of conditions may lead to immediate cancellation of consent.
- 11. Application fee must be paid at the time of submitting this application.
- 12. If approved, the applicants will be advised by way of written confirmation.
