DECISION OF THE WAITOMO DISTRICT LICENSING COMMITTEE

- 1. The application for an on-site special licence is granted. The special licence may issue immediately.
- 2. Waitete Rugby Football Club Incorporated is authorised to sell and supply alcohol, at Waitete Rugby Football Club, 57 Waitete Road, Te Kuiti .
- 3. This licence is subject to the following conditions:
 - (a) A copy of this licence with all the conditions must be displayed in a prominent place so all persons can read it and all staff must be familiar with the conditions.
 - (b) Alcohol may be sold under the licence on the following days and during the following hours:

<u>Te Kuiti Fire Brigade and Emergency Services Christmas Function</u> Saturday 8 December 2018, from 7.00pm to 1.00am the following day

Dellayne Ratima 21st Birthday

Saturday 15 December 2018, from 5.30pm to 1.00am the following day

Inframax Christmas Function

Friday 21 December 2018, from 5.30pm to 12.00 midnight

2019 Annual North Island Sheedshear Champs

Friday 11 January 2019, from 6.00pm to 1.00am the following day.

- (c) Alcohol may be sold or supplied to people present participating in the event this licence is issued for.
- (d) The area where alcohol is to be sold and consumed is described in the plan date stamped as received by the Waitomo District Licensing Committee on 8 November

2018 and no alcohol is to be taken out of this area.

- (e) The holder of a manager's certificate shall be on duty and on the premises at all times alcohol is sold. A sign shall be displayed identify the duty manager.
- (f) The entire premises is undesignated.
- (g) There must be no sale or supply of alcohol to minors or intoxicated persons and there must be displayed at every point of sale appropriate signs detailing these restrictions.
- (h) Drinking water must be freely available from the bar and this must be clear to customers while the premises is open for the sale and supply of alcohol.
- (i) Food must be available for consumption on the premises at all times the premises is open for the sale of alcohol in accordance with the menu submitted with the application for this licence, or variations of a similar range and standard.
- (j) A range of low-alcohol (less than 2.5% by volume) and non-alcoholic drinks must be available at all times when the premises is open for the sale of alcohol.
- (k) A telephone must be freely available for customers to call for transport and staff must assist if required. Telephone numbers for alternative forms of transport from the premises must be displayed. The availability of the courtesy van to transport patrons home from the premises shall be promoted.

REASONS

- 1. This is an application by Waitete Rugby Football Club Incorporated for a special licence for four different events to be held at Waitete Rugby Football Club, 57 Waitete Road, Te Kuiti.
- 2. This application was received more than 20 working days prior to the event as required by section 137 of the Act.
- 3. The Liquor Licensing Inspector, Police and Medical Officer of Health have no objection to this application for a special licence (s 141). Accordingly, this application is decided on the papers (s 202).
- 4. The purpose of the Act is to put in place a new system of control over the sale and supply of alcohol (s 3). The object of the Act is to ensure that the sale and supply of alcohol is undertaken safely and responsibly, and the harm caused by excessive or inappropriate consumption of alcohol is minimised (s 4).
- 5. In deciding whether to grant a special licence the District Licensing Committee must have regard to the criteria in s 142 of the Act. Therefore, this committee must consider the following questions within the framework of the purpose and object of the Act:

- a) What is the nature of the event? Does the applicant propose to engage in the sale of goods or provision of services other than those directly relating to the sale of alcohol, low-alcohol refreshments, non-alcoholic refreshments and food?
- b) Is the applicant suitable?
- c) Will the amenity and good order of the locality be reduced to more than a minor extent by the effects of the issue of the licence?
- d) Are the days and hours during which the applicant proposes to sell alcohol reasonable?
- e) Is the design and layout of the premises suitable? Are any areas of the premises designated restricted or supervised areas?
- f) Does the applicant have appropriate systems, staff and training to comply with the law? What steps will the applicant take to ensure that alcohol is not sold to prohibited persons? g) What proposals does the applicant have in relation to the sale and supply of non-alcoholic
- g) What proposals does the applicant have in relation to the sale and supply of non-alcoholic drinks and food, low-alcohol drinks and the provision of help with or information about alternative forms of transport from the premises?
- h) Have the Inspector, Police and Medical Officer of Health raised any relevant considerations?
- i) Does the application comply with the Waitomo District Local Alcohol Policy?
- 6. The licensing committee may refuse a special licence even if there was no objection to the application (s 144). Sections 146 149 of the Act outline the compulsory and discretionary conditions for a special licence.

Should the special licence be granted?

- 7. The first event is to be held on Saturday 8 December 2018 and is a Christmas Function for the Te Kuiti Fire Brigade and Emergency Services. It is expected that up to 70 people will attend the function. The second event is a 21st Birthday celebration for Dellayne Ratima and up to 90 people will attend. The third event is a Christmas Function for Inframax Construction and up to 85 people will attend. The fourth event is the 2019 Annual North Island Speedshear Champs and up to 160 people will attend. The first three events are by invitation to a select group of people. The Speedshear Champs are open to the public who pay an entry fee.
- 8. The licensing committee is satisfied that the proposed trading hours for each event are reasonable. The application has been assessed by the Licensing Inspector to be compliant with the Local Alcohol Policy.
- 9. The licensing committee is satisfied that Waitete Rugby Football Club Incorporated is a suitable applicant to hold a special licence. The club currently holds a club licence and has demonstrated compliance with the Sale and Supply of Alcohol Act 2012. The issue of a special licence for this event will allow the applicant to sell alcohol to non-members of the club attending the event. Two Duty Manager's will be present on the premises for the duration of each event to ensure compliance with the Act. While two Duty Manager's may not be essential for the smaller events with less than 100 attending, it will be important for the larger Speedshear event to have two certificated managers to ensure that the event is well managed.
- 10. Given the nature of the event and the venue it is not likely that the issue of the special licence will adversely affect neighbouring properties. The licensing committee is satisfied that the design and layout of the premises is suitable given the temporary nature of the

licence.

11. The licensing committee is satisfied that the applicant will provide sufficient food, low alcohol and non-alcoholic refreshments. Free water will be provided at the bar. The use of the Club's courtesy van will be promoted as a safe option for transport home from the event.

Conclusion

12. The licensing committee is satisfied that the grant of the special licence with the appropriate conditions will ensure the safe and responsible supply of alcohol and the minimisation of harm caused by excessive or inappropriate use of alcohol. Therefore, the application for a special licence is granted.
