# A Guide to using your local Transfer Station

Waitomo District Council provides Waste Transfer Stations to the communities of Te Kuiti, Marokopa, Kinohaku, Piopio, Benneydale and Awakino/Mokau.

The aim of these facilities is to provide a convenient place for residents to dispose of their household waste and recycling in an environmentally friendly manner.

Transfer stations are supervised by staff to ensure the facility is used properly and so that maximum recycling is achieved. We encourage residents to use blue rubbish bags to dispose of household waste that cannot be recycled or composted and to recycle household items at the transfer station.

# **Transfer Station Disposal fees**

Items like unofficial rubbish bags, garden waste, televisions will incur a cost at the Transfer station.

Charges are per refuse item: Van (each). If the amount of general refuse is over and above the standard item, additional charges will be applied.

Fees are displayed at the transfer station and on our website. Payment options: cash and cheque. Eftpos is available at the Waitomo District Landfill.

# **Recycle the following waste items**

Recycling is an effective way to reduce the amount of waste sent to Landfill, and to reduce residential and business waste disposal costs. Facilities are provided for residents to recycle plastic types 1 and 2, glass, paper/ cardboard, tin and aluminium cans - at no cost.

### Plastic (types 1 and 2)

Any plastics types 1 and 2 will be accepted for recycling.

#### Not all plastic items are types 1 and 2, so please check for the recycling number on the underside of the item.

Plastics that can be recycled include soft drink bottles, milk bottles, margarine containers, meat trays and clean food packets such as biscuit trays or salad domes.

To prepare your items for recycling, remove all lids and discard. Rinse the items **thoroughly** in warm water. Flatten plastic bottles as much as possible. These can be placed in the plastic collection containers at the Transfer Station.

metals that ARE NOT accepted for recycling:

The Transfer Stations will accept glass bottles and jars. This includes clear, green and brown coloured glass and any glass bottle or jar that contained food or drink.

To prepare your items for recycling, remove bottle caps/ lids (these cannot be recycled) and rinse bottles and jars clean.

#### The following are examples of the types of household glass that ARE NOT accepted for

recycling:

Light bulbs

Drinking glass, ceramics or porcelain.



Window or mirror glass.

Broken glass should be well wrapped in newspaper and put in a rubbish bag, not in the recycling bin.

#### Paper and cardboard

The Transfer Stations will accept paper and cardboard for recycling. This includes clean egg trays/ cartons, cardboard boxes (flattened), newspaper and plain paper.

To prepare your items for recycling - flatten cardboard.

# The following are examples of the types of household paper/ cardboard that ARE NOT accepted for recycling:

Wrap from food items i.e. pizza boxes or any contaminated item. Wax coated paper Polystyrene Insulated/foam cups

# **Waitomo District Council Bylaws**

Council Bylaws are rules or regulations that are created to control specific activities within the Waitomo District. Bylaws help ensure that our community is safe, healthy and vibrant. Bylaws are a useful way of dealing with particular local nuisance problems. **In regards to rubbish and recycling, Council's Solid Waste Bylaw applies.** General provision for Waste Transfer Stations (Section 7):

All persons entering any waste disposal site, transfer station or landfill shall observe and comply with all erected signs, or any instructions given by an authorised officer with regard to operational and safety matters relating to the site or the depositing of waste or recyclable waste therein.

#### No person shall at any waste disposal site or landfill site:

- a) Enter other than for the purpose of depositing waste and/or recyclables and only during such hours as the site is open.
- b) Dispose any special waste without the written consent of an authorised officer and in accordance with whatever conditions may be imposed in relation to the nature of the disposal required, or any charges that may be imposed.
- c) Tip, throw, or deposit any waste in any manner at any place on any waste disposal site which is not intended for that purpose.

An authorised officer may refuse to accept, at any waste disposal site any waste for which fees or charges have not been paid or which, in his or her opinion:

- a) May cause undue hazard to the health and safety of the public or to any operator of the site, or
- b) May damage the environment; or
- c) Cannot be adequately treated or handled by the normal methods used on that site.

All persons using any transfer station facilities shall ensure that:

- a) All waste is separated into recyclable refuse and residual waste categories.
- b) All waste is off-loaded at the place and in the manner directed by the site operator.
- c) All reasonable steps are taken to assist in the minimisation of waste.
- d) All reasonable steps are taken to protect the health and safety of all of those persons on site including site staff.
